Located along the picturesque Merri Creek in East Brunswick, CERES Community Environment Park holds a vibrant community market every Saturday and Wednesday from 9am - 1pm.

CERES Craft Market, open till 2pm, provides local people with an affordable, ethical and friendly way of doing business, both buying and selling, within the village atmosphere of CERES.

The fresh produce we sell are either grown in CERES' own organic market gardens or are bought direct from local Victorian growers. What we can't get from local growers we buy from various wholesalers who source produce from Victoria and interstate. Everything we sell is certified organic. We also have a fantastic organic farm shop stocked with CERES' own fresh laid organic eggs, bulk organic wholefoods, cleaning products, local preserves and lots of other yummy things.

We have organic coffee, incredible organic pastries, cakes and muffins for sale. We also have musicians playing, our chooks and gardens for your shopping pleasure.

ALL YOU NEED TO KNOW ABOUT HAVING A STALL AT CERES CRAFT MARKET

CERES Market is a vibrant community market that focuses on hand-made and recycled items. The CERES Craft Market is held every Saturday and Wednesday running a little longer from **9am to 2pm**

- Location:** Enter the site from the Left-Hand gate at the Lee st. entrance. When entering a vehicle through the site please drive carefully and in 1st gear. The Market is located beside the CERES Organic Food Market at the CERES stables.
- Cost:** **\$15 for a Stall** (which will be collected from you during the morning)
- Set-up:** **7:30am - 8:30am Saturday morning.** Cars may access the site at this time but must be off site by 8:30am. Car entry is from the left hand gate at the Lee street entrance. No trailers are permitted in the market area. Late arrivals must carry stock in.
- Size:** Sites are strictly 2 metres by 3 metres. If you require more room you will need to book extra sites.
- Bring:** Bring your own tables, umbrellas, chairs, smiles etc
- Bookings:** Operates on a "first in first served" basis. If you have problems finding a spot please ask the market co-ordinator who is there from 7.30am. You can book a particular site by paying for it in person at the market a week in advance.
- Pack- up:** Cars can return to site for pack up after 1.45pm.

Stallholders are not permitted to sell mass produced or imported items.



Because of existing CERES Enterprises, Stallholders are not permitted to sell food or plant products.

CRAFT MARKET REGULATIONS

- CERES accepts no responsibility for adverse weather and no refunds will be given for this reason.
- CERES accepts no responsibility for damages to persons or goods as a result of stalls or their products. The stallholder is responsible for injury to any 3rd party as a result of their stall, themselves or their products. CERES encourages stallholders to take out their own insurance.
- CERES has the right to withdraw the right to trade of any stallholder if they are in dispute with CERES or any persons. Right to trade will only be reinstated if the dispute is resolved to the Market CO-Ordinator's satisfaction.
- CERES has the right to reject any stallholder, whom they believe does not comply with the stated regulations.

STALLHOLDERS RESPONSIBILITY

- ◇ Only products listed and approved by the Market Co-ordinator on the current registration form can be sold.
- ◇ It is the responsibility of the stallholder to ensure they conform to any Australian standards pertaining to their product.
- ◇ Copying the ideas and work of other stallholders may be in breach of creative copyright and is not in the spirit of the market. Any grievances must be in writing.
- ◇ Stallholders are responsible for leaving their site and surrounding area clean & tidy. Boxes & rubbish must be removed from market area
- ◇ Stallholders must confine their display and signs to the stall site and keep pathways clear for patrons.
- ◇ Umbrellas & covers must be secure at all times. **Any CERES equipment borrowed by the stallholder (eg. Tables and umbrellas) fall under the responsibility of the stallholder.**
- ◇ Packaging of stallholders products must be environmentally friendly - no new plastic bags please.
- ◇ In the interest of health & safety NO DOGS are permitted to enter the food market selling area. DOGS on site are to be on leads at ALL times.
- ◇ No gas or electrical appliances to be used without prior approval from the Market Co-ordinator. Requests will need to be in writing.

◆ **No smoking is permitted within the food or farm area. Please dispose of butts thoughtfully!**

Stall fee is \$15. Please give your payment on the day to the Craft Market Co-ordinator, who will be on site in the morning to assist you and to collect this form for your contact details.

Stallholders will need to provide their own tables, chairs, shelter etc.
