What we are unable to source from local growers we buy from various wholesalers who supply produce from Victoria and interstate. Everything we sell is certified organic. And we also have a fantastic organic shop stocked with CERES' own fresh laid eggs, bulk organic wholefoods, cleaning products, local preserves and other beautiful organic products of the yummy variety!

The market also has a café area, selling organic coffee and tea, incredible organic pastries, cakes, muffins and other goodies. We also have musicians playing, also our chooks and gardens are for your shopping pleasure.

## WHAT YOU NEED TO KNOW ABOUT HAVING A STALL in **2011** AT CERES **CRAFT** MARKET

CERES Market is a vibrant community venue that focuses on **hand-made** and **recycled items**. The Craft Market is held every Saturday and Wednesday running from **9am to 2pm**

**Location:** Enter the site from the Left-Hand gate besides the Lee St. entrance, **No Vehicles**. The Market is located beside the CERES Organic Food Market.

**Cost:** For a stall will be **\$15** (which will be collected from you during the morning)

**Set-up &**

**Registration:** **7:30 - 8:30am Wednesday and Saturday morning**

**Size:** Sites are strictly 3 x 3 metres. If you require more room you will need to book extra sites.

**Bring:** Your own tables, umbrellas, chairs, sun and rain protection and smiles

**Bookings:** Operates on a "first come first served" basis. **Confirm with Jess (Craft Market co-ordinator)** in securing a suitable position. Jess is there from 7.30am on a Saturday. You can book a particular site by paying for it in person to Jess a week in advance.

**Pack- up:** Pack-up is to be completed before 2pm to ensure site is vacated by (not later) 2pm.

- Handmade work and second-hand items welcome. We support local artisans
- Stallholders are not permitted to sell mass produced or imported items.
- Because of existing CERES Enterprises, Stallholders are **not** permitted to sell **food or plant products**.

If you have any local or certified organic produce that you would like to sell to CERES Organic Market or Shop and any further enquiries about a craft stall please contact the Organic Market Manager on 9389 0100 between business hours Monday to Friday.



### **STALLHOLDERS RESPONSIBILITY & RIGHTS (2011)**

- ◆ Only products listed and approved by the Craft Market co-ordinator on the current registration form can be sold.
- ◆ It is the responsibility of the stallholder to ensure they conform to any Australian standards pertaining to their product.
- ◆ Copying the ideas and work of other stallholders may be in breach of creative copyright and is not in the spirit of the market. Any grievances must be in writing.
- ◆ Stallholders are responsible for leaving their site and surrounding area clean and tidy. Boxes and rubbish must be removed from market area.
- ◆ Stallholders must confine and **secure** their display and signs to the stall site and keep pathways clear for patrons.
- ◆ **Stallholders own umbrellas, gazebos, tables and covers must be secure at all times.**
- ◆ Packaging of stallholders products must be environmentally friendly - **no new plastic bags** please.
- ◆ **In the interest of health and safety NO DOGS are permitted to enter the food market selling area. DOGS on site are to be on leads at ALL times.**
- ◆ No gas or electrical appliances to be used.
- ◆ **No smoking is permitted within the Food, Farm, Craft and Market area. Please dispose of butts thoughtfully! Smoking is permitted in Energy Park area, past the nursery.**

## **CERES Responsibility & Rights (2011)**

- CERES accepts no responsibility for adverse weather and no refunds will be given for this reason.
- CERES accepts no responsibility for damages to persons or goods as a result of stalls or their products. The stallholder is responsible for injury to any 3<sup>rd</sup> party as a result of their stall, themselves or their products. CERES encourages stallholders to take out their own insurance. CERES public liability does not cover Craft Market Stall holders.
- CERES has the right to withdraw the right to trade of any stallholder if they are in dispute with CERES or any persons. Right to trade will only be reinstated if the dispute is resolved to the Market Manager's satisfaction. CERES has a Conflict Resolution procedure available for Stallholders to undertake if they are unhappy with decisions made.
- CERES has the right to reject any stallholder whom they believe does not comply with the stated regulations.
- **Any CERES equipment borrowed (on the day borrowed and until returned) by the stallholder then becomes the responsibility of the stallholder.** CERES will ensure that any equipment borrowed is sound. Any damage to CERES equipment will need to be covered by the stallholder.

Stall fee is \$15 please give your payment on the day to the Craft Market Co-ordinator, who will be on site in the morning to assist you and to collect this form for your contact details. Stallholders will need to provide their own tables, chairs, shelter etc.

Operates on a "**first come first served**" basis. You can book a particular site by paying for it in person at the market a week in advance. To secure a position please ask **Jess** the Craft Market Co-ordinator who is there on a **Saturday** from 7.30am. Bookings will only be taken in person on a Saturday.
